Pursuant to Art. 13, sec. 1-2 and Art. 14 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation, „GDPR”), repealing the Directive 95/46/EC, we would like to inform you that:

1. **The Controller of your personal data** is Beyond Solutions Sp. z o.o. based in Poznan, 11A Kreglewskiego Street. 2. Your personal data may be **processed in particular for the following purposes**:

- a) conducting negotiations, concluding and implementing contracts;
- b) financial and accounting settlements;
- c) conducting marketing activities;
- d) protection of infrastructure;
- e) evidence related to debt collection activities, court disputes, etc.

3. The basis for the processing of your personal data is, in particular:

- a) consent to the processing of personal data for one or more specific purposes, in accordance with Art. 6, sec. 1 (a) of the GDPR;
- b) processing being necessary for the performance of a (service, supply) contract or in order to take steps at your request prior to entering into a contract, in accordance with Art. 6,

c) legal obligation resting with the Data Controller processing being necessary for the purposes of the legitimate interests pursued by the Data Controller or by a third party, in accordance with Art. 6, sec. 1 (f) of the GDPR such as effective communication through contact persons, security and protection of infrastructure, defense against claims and/or debt recovery, direct marketing, improvement of service quality and customer service.

4. **Personal data will be processed** as long as the purpose for which the data has been obtained is being realized not later, have than the expiry of deadlines for submitting claims resulting from legal provisions or the lodging of an effective objection.

5. **The scope of data processed by the Data Controller** includes in particular such ordinary data as: name, surname, contact details such as e-mail address and telephone number, settlement data, image preserved in the video surveillance system.

6. We have received the data **directly from you** (e.g. during a telephone conversation, via e-mail, orally) or indirectly (e.g. from a company you represent).

7. Data **can be transferred to:**

1. subcontractors, e.g. IT service providers and bookkeeping and accounting service providers;
2. other data controllers who provide us with legal services, to the extent to which they are data controllers, as well as payment service providers, banks, insurers;
3. public authorities, to the extent that they are legally entitled to receive it.



8. In connection with the processing of personal data under the terms set out in the GDPR, **you have the following rights:**

- a) the right to request access to and rectification of your personal data;
- b) the right to request erasure of your personal data;
- c) the right to request the restriction of the processing of your personal data;
- d) the right to portability of personal data;
- e) to object to the processing of personal data;
- f) the right to withdraw consent to the processing of personal data, if it has been expressed; withdrawal of the consent does not affect lawfulness of the processing carried out before its withdrawal.

To exercise the above-mentioned rights, the data subject should contact the Controller by sending an email to [iod@beyondsolutions.pl](mailto:iod@beyondsolutions.pl), specifying the relevant Controller. The Controller may request additional information necessary to verify the identity of the individual submitting the request

9. If you come to the conclusion that your personal data is not processed in accordance with the law, **you have the right to lodge a complaint** with the supervisory body (the President of the Office for Personal Data Protection available from the website: [www.uodo.gov.pl](http://www.uodo.gov.pl)).

10. The Data Controller **does not transfer your personal data outside the European Economic Area**, nor to international organizations.

11. Personal data **is not subject to automated decision making, including profiling**.



12. Providing personal data **is voluntary, but refusal to provide it may result** in the inability to conclude the contract, provide services, etc.

13. If due to the conclusion of a contract, provision of a service, etc. you have provided us with personal data of other persons, **please inform those persons about the wording of our information note.**
